## SVL MINUTES

1. **Approval of last meeting Minutes and Agenda**

*Gary will call Hamilton City and Williams to see if he can get a representative from either of those two schools. Mike Owen of Live Oak is the SVL North Rep. Soccer all league meeting will be held in Live Oak at 6:00PM rather than in Williams as originally scheduled.*
6. **Basketball- Game Nights for 2008/9**  
*Different game nights were discussed so players from school teams could watch each other play rather than having to play on the same nights. No action was taken as it was left to individual schools to make agreements with other schools to change game nights occasionally to accommodate this part time.*
7. **Golf Schedule**  
*A discussion of possibilities was initiated. Greg Blake created a spreadsheet showing average amount of school time missed by specific sports at his school. Jim Bard also gave input about logistics and time constraints. Continuing an 18 hole format was discussed. No action taken as it was agreed to continue with existing 18 hole format as it is the format used in playoffs.*
